Subject: Impact Assessment for the Terminally Ill Adults (End of Life) Bill

Dear Mr Streeting,

As the Terminally Ill Adults (End of Life) Bill ('the Bill') is a Private Members' Bill, it did not receive an Impact Assessment prior to its Second Reading. Now that it has completed Committee Stage, the Government has undertaken to prepare an Impact Assessment which will be presented to Parliament prior to the Bill being considered at Report Stage.

I am writing to ask for an assurance that this Impact Assessment will involve full and detailed consideration of the potential impact of the Bill on equalities and human rights.

Due consideration of the impact of the Bill on equalities and human rights would seem to require, at a minimum, that the Impact Statement has the approval not only of the Secretary of State for Health and Social Care, but also the Secretary of State for Justice, the Minister for Social Security and Disability, and the Minister for Women and Equalities, and that opinion on these aspect of the Bill has been sought from the Equality and Human Rights Commission.

While the Public Bill Committee did not provide an assessment of the impact of the Bill on equalities and human rights, it heard written and oral evidence that is relevant to such an assessment. I would therefore urge that those drawing up this aspect of the Impact Assessment consider the following evidence:
